➤ **OLD BUSINESS**

Eric Cooper gave an update on the changes that have been made to the Parks and Recreation Master Plan since the last CIC meeting. The list of changes requested by the Town Board have been addressed and are now an addendum to the Draft Plan. The Town Board is considering the adoption of the plan at their next Town Board meeting on February 12th.

➤ **NEW BUSINESS**

1. The new Cultural and Historic Preservation Project Team had their first meeting Wed Jan 31st. There are 10 members on the team - many with experience working or volunteering with historical societies both here and elsewhere. The team is preparing to apply for a Preserve NY grant to conduct a reconnaissance survey of historically significant properties in the town with guidance from one of the team leaders, Saralinda Hooker, who has extensive experience with these grants. The result, if the grant was awarded, would be an inventory of properties that could be used in the future to apply for National Register of Historic Places designation and also used as an educational tool to inform our public.
2. Joyce lead a review of the final draft of the Ridgeline Viewshed Law. Copies of the draft were passed around. CIC members commented and discussed each section. Next step: these comments will be considered along with the rest of the text by the Ordinance Committee.

They will make a recommendation to the Town Board.

- Joyce announced that the NRI team will be dissolved after this draft is passed to the Ordinance Committee. The Ordinance Committee will also be responsible for finalizing a Shorelines law, if that is the direction they choose to go in.
