- **CALL TO ORDER**

- The meeting was called to order by the Chair at 6:04 pm.

- **PRIVILEGE OF THE FLOOR**

- Ag Committee members were invited to attend the February 24<sup>th</sup> volunteer and 2020 project kick-off meeting to represent the Committee.
- Doug mentioned that we still could use a few more people on the committee. Someone suggested that we reach out to Wegmans Organic Farm to see if they have someone who would be interested.
- Sarah thanked Bob for his contribution to the last newsletter – Fun Facts. There was a discussion about the Ag Committee’s future newsletter contributions. Tim Riley agreed to write an article for the March issue.
- There was a discussion about the old Genecco produce stand next to Ace Hardware on St Rt. 332 and the possibility of local growers using it as a year-round market. If someone local wanted to spearhead this project, it has the potential to be a great resource for both community members and growers. Tim Riley said he would contact the Canandaigua Farmers’ Market to talk to them about it.

- There was a brief discussion of the survey for the Comprehensive Plan update and the comments that community members provided relative to agriculture. It was agreed that the Ag Committee should review these comments and discuss them at the next meeting.
