I just wanted to make you aware that the schedule put out in the January organizational TB meeting was just a draft schedule for presentations to the Town Board by the various town boards and committees. We have made some adjustments for schedules and other needs, and you will not be presenting in March. Instead, the ECB and the Tree Team will be presenting.

One item I would like your input on is a "Meeting of the Boards". This would be a joint public meeting of the Planning Board, the Zoning Board and the Town Board. Looking back at minutes from years ago, I noticed that meetings like this were held. A meeting like this would give us the chance to discuss openly where we see code or procedural changes that might be needed, or ways to really improve on things we already do well. It would be the only item on the agenda, so it would take the full 90 minutes. We would arrange a facilitator to help guide and capture the discussion. It would most likely be a few months out, maybe May or June, so we could get it all scheduled.

Planning and Zoning Boards, please discuss as boards and have each chair get back to me with a yes or no and how many could meet on May 13^{th} or how many could meet on June 10^{th} . If there are any specific questions, feel free to reach out. My hope is to make this a regular meeting and improve the communication, planning and interaction between our boards.
