

Food Recycling Now Underway at the Town Transfer Station

The Town of Canandaigua is excited to start offering food recycling to its residents. The program began on June 30. The Town is joining with Natural Upcycling of Linwood, N.Y.—Upstate New York’s premier food scraps/organics collection company—to collect and recycle food waste.

All types of food waste can be recycled at the Transfer Station including fruit and vegetable scraps, meat and bones, wheat products (bread, pasta, cereal), dairy products, egg shells and coffee grounds. Leaves, grass clippings, and paper towels can all be included as well. Even shredded paper, which cannot be included with single-stream recycling because it clogs the sorting machine, can be recycled with the food waste.

Please be sure to keep the food waste free of contaminants such as plastics of any kind, aluminum foil, wood or metal.

Bring your food waste to the Transfer Station during the regular hours of operation either in the Town-provided bins (available at the Town Clerk’s office



to the first 100 residents) or in a bin of your choice. Upon arrival, simply put the food waste in the orange Natural Upcycling totes at the Transfer Station.

Interested in composting in your own backyard instead of at the Transfer Station? A handmade wooden compost

bin, worm casting compost accelerator and informational materials can be delivered to your home for \$20. This is available to the first 100 residents who sign up at the Town Clerk’s office.

New Traffic Pattern at the Transfer Station



Traffic for the Transfer Station will now enter straight through the gate toward the Highway Facility and to the right. Motorists can pull up with the Transfer Station on your right to unload. To exit, continue straight and circle around the far end of the highway complex. Traffic will move in a counter clockwise manner.

Francis Granger
1792-1868


Francis Granger, second son of Gideon Granger, entered Yale College at the age of sixteen, graduating in 1811. When Gideon moved to Canada in 1816, Francis followed and practiced law alongside his father, building a house just one block north of the family homestead.

Elected to the State Assembly in 1825, Francis was a follower of Governor DeWitt Clinton. In 1834, he was elected to Congress and when, in 1836, William Henry Harrison was elected as President of the United States, he selected Francis Granger as Postmaster General. Due to Harrison's untimely death, Francis served only 7 months, leaving Washington and returning to Canada where he practiced law until his death.

The 1841 Census Catalogue shows the death of President William Henry Harrison. It reads: "Gideon Granger, 68 years old, died at York."




Gideon Granger
1767-1822

Gideon Granger was an attorney, land developer and gentleman farmer. He served as Postmaster General of the United States for 13 years (1801-1814) under Presidents Jefferson and Madison, the longest term served by any Postmaster General. Granger was chosen by Jefferson to fill this position because he was a prominent Yale-educated lawyer, a clever politician, a natural businessman and a powerful personality.

Gideon Granger was essential with doubling the miles of post roads to 40,000 and tripling the number of post offices to 2,700 while serving as Postmaster General. During his tenure, the status of Postmaster General was for the first time equal to other Presidential positions of the Cabinet.

Protect Our Lake: Invasive Species Workshop August 9th

Join the Town Environmental Conservation Board on Thursday, August 9th at Onanda Park (4965 County Road 16), from 6:00 p.m. to 8:00 p.m. for an Aquatic Invasive Species Workshop.

The workshop will be presented by Bruce Gilman, Ph.D., Professor of Environmental Conservation at Finger Lakes Community College and Director of the Muller Field Station. His teaching expertise includes aquatic ecology, field botany, glacial geology and environmental chemistry.

This hands-on presentation with samples of local invasive species found in Canandaigua Lake will offer a free family-friendly opportunity to learn about non-native species and what we can do about their infestation.

The introduction of non-native species is likely to cause economic harm, environmental harm or harm to human health. An invasive species is able to maintain its life cycle within the local area. Although many non-native species are desirable (most agricultural crops and animals are non-native), unwanted invasive species cost time, effort and money to keep them at bay.

So, what do Eurasian water milfoil, Didymo, Water chestnut, Purple loosestrife, Hydrilla, and Starry stonewort have in common? They are all species from other parts of the world that have been accidentally introduced and which have flourished in our lake.

Some of these species were introduced into New York via ballast water discharge as ships from ports around the world travel up the St. Lawrence Seaway and into the Great Lakes.

And, as anglers and boaters move from water to water, these invasive species can be unknowingly spread. This can occur by failing to properly dry or disinfect boating and fishing equipment. Anglers and boaters are asked to be aware of the part they play in the spread of invasive species and take



action to help stem their spread. A boat steward from the Canandaigua Lake Watershed Association will demonstrate proper boat cleaning during the presentation.

For all you aquarium aficionados, did you know that many exotic aquatic plants have been introduced through the home aquarium trade? Invasive plants such as Brazilian elodea, fanwort, and hydrilla are often sold as oxygenators for aquariums. These

plants can become established in the wild and cause dense infestation that compromise water quality or recreation and human consumption if they aren't disposed of properly.

Be on the alert for these intruders! And help us keep an educated eye on Canandaigua Lake.

Recycling Facts

For every **ton of paper** recycled, we save 463 gallons of oil, 7,000 gallons of water, 3 cubic yards of landfill space, 4,100 kilowatt hours of energy and 17 trees. We also produce 60 pounds less of air pollution and we reduce carbon dioxide emissions by 850 pounds per year.

For every **ton of glass** recycled, we save 9 gallons of fuel oil, 1 million BTU's of energy, 1,330 pounds of sand, 433 pounds of soda ash, 433 pounds of limestone, 151 pounds of feldspar, and 25 percent of the energy necessary to make glass with virgin materials. For every **glass bottle recycled**, we save enough energy to light a 100-watt light bulb for four hours.

Lifetime Learning: Senior Citizens Course Audits at FLCC

Senior Senior citizens have the opportunity to continue their lifetimes of learning through the Senior Citizens course audit option at Finger Lakes Community College (FLCC):

FLCC permits persons 60 years of age or over to audit courses without tuition, examination, grading or credit on a space-available basis with the permission of the instructor. This auditing

privilege is restricted to courses that are offered for college credit. Any materials or supplies that are needed for class and which are not covered by normal tuition will be the responsibility of the person auditing the class. This includes textbooks, lab supplies or special course-related fees.

On sunny days, hang your clothes outside on a clothes line.


- This will reduce your electric/gas bill and will leave your clothes smelling fresh.
