The ZBA shall hear and decide appeals when it is alleged there is an error in any requirements, decisions, determination made by the Local

Administrator in the enforcement or administration of the Zoning Chapter of the Code. Interested candidates should have a background in or an understanding of code language and land use planning. The ZBA has one vacancy: Alternate board member position, which is paid \$68.00 per voting meeting, that serves when a regular member is unable to attend a meeting. ECB members are involved in planning ECB meetings, project reviews, public workshops or events, etc. Applicants having a background in conservation, natural resource management, land use planning, or a related field are strongly encouraged to apply. ECB members receive a stipend that is paid quarterly.
